WHALEHEAD CLUB PICNIC SHELTER RULES AND REGULATIONS

Currituck County and the Whalehead Preservation Trust are happy to provide a covered picnic shelter on the Whalehead Club grounds for your enjoyment. We're glad you're here and hope you will enjoy the natural beauty and historic significance of the area, all within walking distance!

1. The Picnic Shelter is open from 6:00 A.M. until 9:00 P.M. Reservations are encouraged and can be made by calling the Whalehead Club office at 453-9040. Reservation Agreements must be signed and on file in the office. Use of the shelter is free but requires a \$25.00 deposit, payable to The Whalehead Preservation Trust. The deposit will be returned if the shelter and surrounding area has been left clean, free of litter, etc. The person signing the Reservation Agreement is held liable for cleanup and any damages or maintenance fees incurred as a result of his/her group's activities.
2. Alcoholic beverages and illegal drugs are not allowed anywhere on the Whalehead Club grounds, including the picnic shelter.
3. Nailing decorations to the shelter is not allowed. However, taping is permitted
4. No one may charge a fee to enter or use the Picnic Shelter.
5. Parking is in designated parking areas only.
6. Violation of any of these Rules and Regulations may result in expulsion from the picnic shelter and/or Whalehead Club grounds and possible denial of future privileges.
