



2010 Flag Football & Cheerleading Registration Form

Currituck County Parks and Recreation Department



Registration is now open for Currituck County's Parks and Recreation Youth Flag Football/Cheerleading League to all students who have reached the age of 5 prior to August 1, 2010 and who have not reached the age of 13 prior to August 1, 2010. A \$20.00 registration fee per child will be charged with a maximum of \$40.00 per family. This money will be used to provide insurance, awards, as well as a shirt for football and cheerleading poms for cheerleaders that will be kept at the end of the season. Additional fees may be added for cheering uniforms.

Registrations will be accepted in the following manner:

- 1) **By mail until October 1st, 2010**, by sending a completed and signed registration form with the proper fee made payable to:

- 2) **In person on October 2nd, 2010 between the hours of 9:00am and 12:00pm in the lobby of Currituck County Parks and Recreation building.**

Teams will be formed following this registration date; **ANYONE REGISTERING AFTER OCTOBER 2ND, WILL HAVE TO PAY A \$5.00 LATE FEE PER CHILD AND WILL BE ALLOWED TO REGISTER IF THERE ARE ANY OPENINGS ON A TEAM!**

Notification of practice times and sites will be made during the following weeks. Please make sure to include phone numbers for this purpose.

As always, coaches are needed in all age groups. Without parents willing to volunteer, there may be children who will not be able to participate. If you are willing to coach a team, please indicate in the space provided on the registration form. Remember, without you, your child may not have a coach!

PARENTS CODE OF CONDUCT

As a parent of a child participating in an athletic program with the Currituck County Parks and Recreation Department I agree to abide by the following rules of conduct while my child is participating, be it in game play or during practices. I understand that failure to follow these rules may result in loss of privileges to watch my child's participation. My signature acknowledges that my spouse and/or I have read and understand the following codes of conduct:

1. I will teach my child that honest effort is as important as victory so that the result of each game is accepted without too much disappointment.
2. I will remember that children learn best by example. I will applaud good plays by our team as well as the opposing team.
3. I will encourage my child to play by the rules.
4. I will try to help my child understand that his/her overall development, improvement, social interaction, and good sportsmanship are more important than winning or losing ball games.
5. I will never ridicule nor yell at my child or another child for making a mistake or losing ball games.
6. I will not publicly question the official's judgment and never their honesty.
7. Under no circumstance will I enter the field/court of play.
8. I will recognize the value and importance of volunteer coaches. I will talk to the coach privately.
9. I will strive to support my child's involvement in sports and to maintain realistic expectations about this involvement.
10. I will not make negative comments to players, parents, officials, or coaches of either team.
11. I will remember that I am a youth sport parent and that the game is for the children not for adults.

I, hereby, give my child permission to play soccer in the Currituck County Parks and Recreation Youth Soccer league. I further agree that the league or its representatives will not be held responsible for any accidents or injuries received while participating in this program above the limits covered by the insurance company.
