\$20.00 delayed birth documents prepared and registered in the local county

10.00 delayed birth documents prepared in another county and registered locally

10.00 delayed birth documents prepared locally but registered elsewhere

10.00 each – certified copy of birth certificate

10.00 preparation of all documents for legitimation

15.00 amendment – preparation and affecting correction of birth record

**Death**

\$10.00 each – certified copy of death certificate
