



2018 Tackle Football Registration Form

Currituck County Parks and Recreation Department



Registration is now open through July 23, 2018 for the Currituck Storm Football Teams. Anyone registering for these teams must have reached the age of 7 prior to August 1, 2018 and must not have reached the age of 13 prior to August 1, 2018.

Anyone on a School Football team is ineligible for play.

There will be a registration fee of \$25.00. This money will be used to provide insurance and help recover a small portion of the cost to supply and maintain the needed equipment.

All players must provide an eligible birth certificate to participate.

Anyone wishing to participate must meet weight requirements for each group:

- 7-8 year old team – no more than 120 pounds
- 9-10 year old team – no more than 160 pounds
- 11-12 year old team – no more than 185 pounds

My signature acknowledges that my spouse and/or I have read and understand the following codes of conduct.

1. I will teach my child that honest effort is as important as victory so that the result of each game is accepted without too much disappointment.
2. I will remember that children learn best by example. I will applaud good plays by our team as well as the opposing team.
3. I will encourage my child to play by the rules.
4. I will try to help my child understand that his/her overall development, improvement, social interaction, and good sportsmanship are more important than winning or losing ball games.
5. I will never ridicule nor yell at my child or another child for making a mistake or losing ball games.
6. I will not publicly question the official's judgement and never their honesty.
7. Under no circumstance will I enter the field/court of play.
8. I will recognize the value and importance of volunteer coaches. I will talk to the coach privately.
9. I will strive to support my child's involvement in sports and to maintain realistic expectations about this involvement.
10. I will not make negative comments to players, parents, officials, or coaches of either team.
11. I will remember that I am a youth sport parent and that the game is for the children, not the adults.

I, hereby, give my child permission to play in the Currituck County Parks and Recreation Youth Tackle Football League. I further agree that the league or its representatives will not be held responsible for any accidents or injuries received while participating in this program above the limits covered by the insurance company.
