Registration is now open to all Currituck County youth who have reached the age of 5 prior to September 1, 2018 and who have not reached the age of 13 prior to September 1, 2018. A \$20.00 registration fee per child will be charged with a maximum of \$40.00 per family. This money will be used to provide insurance, awards and uniform.

Registrations will be accepted in the following manner:

- 2) By mail until June 22, 2018, by sending a completed and signed registration form with the proper fee made payable to:

ANYONE REGISTERING AFTER JUNE 25 WILL HAVE TO PAY A \$10.00 LATE FEE PER CHILD AND WILL BE ALLOWED TO REGISTER ONLY IF THERE ARE ANY OPENINGS ON A TEAM!

PARENTS CODE OF CONDUCT

As a parent of a child participating in an athletic program with the Currituck County Parks and Recreation Department I agree to abide by the following rules of conduct while my child is participating, be it in game play or during practices. I understand that failure to follow these rules may result in loss of privileges to watch my child's participation. My signature acknowledges that my spouse and/or I have read and understand the following codes of conduct.

1. I will teach my child that honest effort is as important as victory so that the result of each game is accepted without too much disappointment.
2. I will remember that children learn best by example. I will applaud good plays by our team as well as the opposing team.
3. I will encourage my child to play by the rules.
4. I will try to help my child understand that his/her overall development, improvement, social interaction, and good sportsmanship are more important than winning or losing ball games.
5. I will never ridicule nor yell at my child or another child for making a mistake or losing ball games.
6. I will not publicly question the official's judgement and never their honesty.
7. Under no circumstance will I enter the field/court of play.
8. I will recognize the value and importance of volunteer coaches. I will talk to the coach privately.
9. I will strive to support my child's involvement in sports and to maintain realistic expectations about this involvement.
10. I will not make negative comments to players, parents, officials, or coaches of either team.
11. I will remember that I am a youth sport parent and that the game is for the children, not the adults.

I, hereby, give my child permission to play in the Currituck County Parks and Recreation Youth Soccer League. I further agree that the league or its representatives will not be held responsible for any accidents or injuries received while participating in this program above the limits covered by the insurance company.
