Sealed bids for the COROLLA BEAUTIFICATION PROJECT will be received by Currituck County until **10:00 a.m. on November 15, 2017**, at the Historic Currituck County Courthouse, Board of Commissioners Conference Room, Second Floor, Suite 205, located at 153 Courthouse Road, Currituck, North Carolina 27929 and then publicly opened and read. The scope of work for this project will include the purchase and installation of select planting materials as specified in the plans and specifications provided along six designated locations along NC Highway 12 ROW from the Currituck County Line to Corolla Village in Corolla, North Carolina.

Each bid must be accompanied by cash or a certified check, drawn on a bank or trust company authorized to do business in North Carolina, payable to Currituck County in an amount at least equal to five percent (5%) of the total amount of the bid, as a guarantee that a contract will be entered into. In lieu of cash or a certified check, the Bidder may submit a bid bond in the form prescribed in G.S. 143-129 as amended by Chapter 1104 of the Public Laws of 1951.

Contractors are notified that North Carolina G.S. 87 relating to licensing of contractors will be observed in receiving bids and awarding contracts. All bidders must be Licensed North Carolina Landscape Contractors.
